- Challenges - shortly after I took over as Chair the Infant School was inspected and we received a 'Good' judgment. The Junior School was inspected six weeks later and received a 'Requires Improvement' judgment, largely due to the lack of data on the progress of PPG children. I oversaw the implementation of the recommendations in the Ofsted report and 18 months later at the monitoring visit the Ofsted Inspector stated: "Governors moved quickly to address the issues raised by the last inspection. They have significantly improved the way they check the progress of all pupils. As a result, governors are now fully aware of the progress that disadvantaged pupils make and closely monitor how well pupils who have special educational needs and/or disabilities get on."
